A PROPOSED GROUNDWATER PROTECTION ORDINANCE OVERLAY DISTRICT FOR WARNER

Findings from the Dec 13 **Public Meeting on Groundwater Protection**

Townspeople and property owners in Warner had the opportunity to talk with the Warner Groundwater Protection Committee in December to learn about our findings related to groundwater and aquifers in Town and what we can do locally to better protect our drinking water resources. This examination focuses roughly along the Warner River- see map on Page 2.

These valuable groundwater resources have little protection. Development at Exit 9 will continue and will eventually span to Exit 7. Incompatible future development over this area without regulation can harm our groundwater.

Conclusions

We drafted the proposed **Groundwater Protection Ordinance** (GPO) Zoning Overlay District language and map to give Warner some local control over *future* and *expanded* incompatible land uses within our vulnerable water resource areas.

Next Steps – We Need Your Support at the Jan 30 **Planning Board Meeting**

The Planning Board held the proposed GPO's 1st public hearing on Jan 9 and will hold the 2nd and final hearing on Mon, Jan 30 at 7:00 PM to decide whether to place the proposed GPO onto the Tues March 14 ballot. <u>Click here for the public</u> notice, proposed GPO and Zoning map on the Town website.

WHAT WARNER'S PROPOSED GPO DOES AND DOES NOT DO

Does:

- **☑** Propose a protection zone over the aquifer and wellhead protection areas which provide our public drinking water.
- **✓** Prohibit a few new or expanded industrial uses that could lead to aquifer contamination.
- **☑** Fit within Warner's existing regulatory structure of zoning districts and uses.

Does Not:

- Regulate private residences.
- Cost the Town money to implement.
- **☒** Discourage new businesses along the Exits 7-8-9 area.

The US Environmental Protection Agency (EPA) provides information about what citizens can do to protect drinking water sources. Their tips include:


- Learning about your drinking water sources.
